
1. The Department of Natural Resources may file a brief-in-chief no later than June 2, 2006.
2. All Parties who support the DNR's Order dated April 15, 2005 (Hearing Exhibit 8) may file a brief-in-chief no later than June 16, 2006.
3. The Petitioners and all Parties who contest the DNR's Order dated April 15, 2005 may file a brief-in-chief no later than July 21, 2006.
4. The DNR and any Party who filed a brief-in-chief in support of the DNR's order dated April 15, 2005 may file a reply brief no later than August 9, 2006.

Any brief-in-chief may be accompanied by proposed Findings of Fact and Conclusions of Law, but such papers are neither required nor anticipated by the Division of Hearings and Appeals.

Filing and service of briefs shall be deemed complete upon mailing by first class mail, but all counsel of record shall provide other counsel of record and the Division of Hearings and Appeals with electronic versions of the written briefs by email sent contemporaneously with mailing.
